Speaking 1 (30 marks)

There are 10 questions. Invigilators may change the questions, but the new question should be of an equivalent level of difficulty.

Question 1 is the confidence giving question, all candidates should get 3 marks.

The other questions each have a supplementary question, the first part gains 2 marks for a correct understandable answer, regardless of whether it is a complete sentence (this is conversation), one word answers may gain 1 mark. The remaining 1 mark is for an understandable answer to the supplementary question.

Ignore incorrect or missing mutations.

Speaking 2 (20 marks)

Introductory remarks (the first 3 or 4 sentences)

Relevant and correct 5 - 6 marks

Relevant but some errors 3 - 4 marks

Mostly relevant, many errors 1 - 2 marks

Response to discussion

Fluent, obvious understanding, few errors 11 - 14 marks

Quick to respond, understanding good, some errors 7 - 10

Responds when prompted 4 - 6

Usually one word answers only, understanding poor < 4
